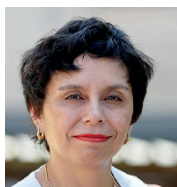

**Florencia Ortúzar**, Director, Climate Program, AIDA.

Lawyer from Pontificia Universidad Católica de Chile and Master's in Environmental Policy and Regulation from the London School of Economics. Based in Santiago, she leads AIDA's Climate Program and coordinates the Climate Finance Line, supporting the organization's efforts on climate and ecosystem protection across Latin America.



**Pilar Moraga**, Director, Center for Climate and Resilience Research CR2.

Full Professor at the Faculty of Law, University of Chile. She holds a Ph.D. in Law from the University of Lille 2, France, and serves as Director of CR2 and the Environmental Law Center at the University of Chile. Her research focuses on environmental law, climate change, and energy policy.



**Carina Costa de Oliveira**, Professor, University of Brasília (UnB), Brazil.

Professor at the University of Brasília School of Law. She holds a Ph.D. in International Law from the University of Paris II–Panthéon Assas and postdoctoral degrees from the University of Cambridge and the University of Adelaide. Her work focuses on international and environmental law, the sustainable management of natural resources, and the interconnections between economic law, the law of the sea, and environmental governance.



**Danielle Moreira**, Associate Professor, Pontifical Catholic University of Rio de Janeiro (PUC-Rio), Brazil.

Associate Professor at PUC-Rio, where she teaches in the undergraduate, master's, and doctoral programs in Law. She founded and coordinates the research group Law, Environment, and Justice in the Anthropocene (JUMA), which develops the Brazilian Climate Litigation Platform and conducts research on environmental and climate law in the Anthropocene context.
